


Total Capital Asset

Displayed as a percentage of total Capital Asset Acquisition Cost Value. General Property only.



Metric includes only Capital Assets Not In Use for these claimancies.


FY-04 Acquisition Cost Errors Summary



Metric includes total records **added** to DPAS during the month with an acquisition cost equal to \$1.


6,113 records have an acquisition cost equal to \$1.00, representing 1.3% of total DPAS records.

Parameter measures only those records added to DPAS during the month with an acquisition cost value of \$1.


FY-04 Asset Category Errors Summary



Displayed as a percentage of the total (General and Military Equip) DPAS records.



FY-04 Asset Identification Errors




Metric includes records with incorrect serial numbers and/or location fields annotated “unassigned”.

Asset Identification Errors


Incorrect Ser #'s = 11

Total location errors decreased by 259 records since July 04.

FY-04 Bar Code Errors




Percentage of records with Last Inventory Date after 01 Oct 2001 and have an incorrect Bar Code format.


FY-04 Bar Code Errors August 2004

FY-04 System Use-UICs Summary




Above metric displays the percentage of UICs converted to DPAS, that had at least one User logon to DPAS during the month.



Percentage of UICs by Major Claimant.


FY-04 System Use - USERS Summary



Includes the number of Users logging onto DPAS during the month. Displayed as a percentage of the total number of Users having access to DPAS.



Percentage of Users logging onto DPAS by Major Claimant.


FY-04 Inventories Past Due Summary


FY-04 Inventories Past Due August 04



Displayed as a percentage of total (General and MIL EQUIP) DPAS records by Major Claimant.


