


FY-04 CNI Capital Asset Errors Summary



Displayed as a percentage of total Capital Asset Acquisition Cost Value. General Property only.




Capital Asset Error rate displayed by UIC.






Acquisition Cost Errors displayed by UIC.




Asset Category Error rate displayed by UIC.
























Percent of Users logging into DPAS by UIC.


Percent of Users logging into DPAS by UIC.








Displays the number of UICs meeting each of the eight DPAS Performance Measures (Metrics).
